

NOMINEE SUBMISSION FORM

The Institute of Noise Control Engineering William W. Lang Award recognizes individuals who have the characteristics of a distinguished noise control engineer, through conspicuous and consistently outstanding service to the Institute and to the field of noise control engineering over a sustained period. This honor corresponds to the title "Distinguished Professor" in academia and to an Honorary Fellowship Award of other professional societies.

This recognition does not involve a new grade of membership. This Award is to be offered every other year.

This form is for the nomination of a candidate for consideration by the Board of Directors of the Institute of Noise Control Engineering for the William W. Lang Award. The Nominator shall be a Board-Certified member of INCE-USA. The completed submission form shall be submitted with a letter that elaborates on the Nominator's reasons for considering the Nominee for the Award. The submission shall also include seconding letters from the references listed in the completed submission form. At least two of these references are to be Board Certified members. These seconding letters shall provide further support why the Nominee should be considered for the Award.

The entire package of nominating information (the nominator's letter, the completed submission form and the seconding letters from references) must be received by the Vice President of Honors and Awards before:
